### **PUBLIC COMMENT**

**MINUTES & TREASURER'S REPORT:** Minutes of the previous meeting were approved with no alterations or corrections, motion Mr. Myers, second Mr. Barron. Treasurer's Report for the month of March 2014 was accepted by motion of Mr. Myers, second Mr. Barron.
