The meeting started with the group saying the Pledge of Allegiance.

Treasurer Ken Houck will give his report at the next meeting but discussed:

Ken said we received the first part of the COVID grant money and asked if the board would like to move forward with Wagner Dreese and Elsasser and Associates, P.C.(WDE) to help with our plans on how to use this money. **Supervisor Shultz motioned to accept the contract with WDE for professional services to help manage the for the COVID funds. Supervisor Whelan seconded. Motion passed.** Ken said Lisa from WDE will send an engagement letter for signatures so we can get the ball rolling.

Zoning officers Dean VonBlohn had no report:

DSI Lead Lloyd Craig gave his report and discussed:

Lloyd discussed work done since the last meeting: trees down, overtime, prep work for paving and mowing. Paving prep work, checking drains and roadways after storms & placed reflectors on Red Lane.

Lloyd said they lowered a catch basin and repaired a sink hole in Edgewood.

Lloyd said they are seeing a huge problem with bushes, trees, tree limbs & shrubs growing out over the roadways, which are causing visibility problems and also blocking signs. He asked the residents to please take care of trimming any of these problem areas.

Fire Chief Leslie Young gave her report and discussed:

Fire Chief Young discussed calls, incidents, carbon monoxide, average response times for dispatch to arrival, dispatch to enroute and average time on scene, in house training sessions, accidents, power lines down, false alarms, building fires and a vehicle fire.
