Chairman Lynn also discussed tentatively adopting the 2021 Budget and said if approved, it will be available for review Wednesday on our website or you can stop by the township building for a hard copy.

Supervisor Whelan motioned to tentatively adopt the 2021 Budget, above. Supervisor Shultz seconded. Motion passed. Supervisor Whelan said that if anyone has comments concerning the budget to join the next meeting to express their thoughts or concerns before final adoption on December 14th.

Chairman Lynn asked for public comment or questions – No Comment.

Supervisor Scott briefly discussed moving the money at JSSB from the account that can be drawn from several times a year. Supervisor Robertson said this money cannot be moved until April of 2021.

Chairman Lynn asked for public comment. No comment.

Chairman Lynn briefly discussed the possibility of donating to the Hero's fund. The last the township donated was in 2018, for \$250. This is for Troops at Valley Township Reserves Center service men and women, that are deployed over the holidays. If approved, this would provide some form of support to the families. Supervisor Robertson motioned to donate \$250 to the reservists and their families. Supervisor Shultz seconded. Motion passed.

Chairman Lynn reminded residents about the leaf pickup every Tuesday and Thursday, ending Thursday, December 17th.

Chairman Lynn asked for public comment not related to new business:

Resident Kathy Mordan expressed concerns about the Magnolia Court dumpster sites that will visible from her home.

Supervisor Shultz motioned to adjourn. Supervisor Whelan seconded. Motion passed.
